**Information on data subject rights**

The processing of the data is based on consent. This consent can be revoked at any time with effect for the future. In the event that we are no longer allowed to pass on your data to the cooperation partner, it will no longer be possible for the cooperation partner to provide support. Accordingly, the cooperation partner will no longer receive remuneration from investify.

You can obtain information about the data processed about you at any time. You have the right to demand that we correct stored data without delay. The same applies to the possible completion of stored data, which can also be exercised in the form of a counterstatement. Deletion of your data is only possible insofar as we do not have to keep this data for the fulfilment of our supervisory duties. As soon as the purpose of the data processing is no longer given, we will delete your stored data. We will communicate your request for deletion to our cooperation partner, so that they too can carry out the deletion you have requested.

You also have the right to restrict the use of your data at any time. If this means that we are no longer able to fulfil the asset management contract, we reserve the right to terminate the contract with you.

On the basis of the basic data protection regulation, you have the right that we transfer your data to a third party named by you or that we transfer your personal data to you on a data carrier.
